(a) Payment of HRA at 30 % to RGNIYD employees

The Director, RGNIYD raised the issue of HRA at 30 % for RGNIYD employees in view of the communication received from the Ministry of Finance, Department of Expenditure. It was decided to legally examine the case so that the same can be taken up personally by the Minister of State (IC), MoYAS with the Ministry of Finance for favourable decision. The examples of Indian Institute of Information Technology, Design and Manufacturing (IIITD & M), Melakotayur Village, Chennai (within 3.1 k.m. from the Municipal limits) and National Institute for Empowerment of Persons from Multiple Disabilities (NIEPMD), Muttukadu (within 6.4 k.m. from the limits) were cited. As RGNIYD is located within 7.1 k.m. within the prescribed Municipal limits of 8 k.m., given the importance of Institute of National Importance and the need for attracting senior academicians, the Minister said that the case for payment of HRA at 30 % to RGNIYD employees need to be resolved favourably.

(b) Establishing a regional centre at Chandigarh using the existing infrastructure facilities of Commonwealth Youth Programme (CYP) Regional Centre, Chandigarh

As CYP RC is winding up their activities, necessary efforts will be made to establish regional centre of RGNIYD at Chandigarh using the existing infrastructure facilities of CYP Regional Centre, Chandigarh.
