## Agenda Item No 1.

At the outset, the winning Architect, Shri Suresh Goyal mad presentation of the architectural plan with the help of the model, he submitted during the competition. MOS(YA&S) suggested some m changes in the plan, with a view to optimise some of the facilities catering. Dr Hira Singh suggested that the Director's residence should near the Guest house, making it easier for the Director to interact with guest faculty. The Architect took note of the suggestions. Agenda Item No 2.

JS(YA) desired that the break up of honorarium paid to the part time NSS employees may be submitted to him.

Agenda Item No 3.

OSD, RGNIYD informed that the progress of the proposed course on "Project Formulation & Implementation" in collaboration with the CYP: Asia Centre was satisfactory. He informed that TTTI Bhopal has taken the responsibility of looking after the academic part of the Course. It was decided to invite Hon'ble HRM for the inaugural session and Shri Salman Khurshid, Hon'ble MOS(EA) for the valedictory session.

Other points.

The Executive Council decided that RGNIYD should purchase the additional piece of land of 18 acres adjacent to the land already in possession of RGNIYD as was previously agreed to in an earlier meeting. It was also decided that RGNIYD would take upon the responsibility of preparing the SAARC charter of Youth.
