The **Research** Scholar shall submit a copy of the synopsis of his/her re-search work prepared in accordance with the format and specification prescribed, to the Doctoral Committee through the **Research** Supervisor. If the Doctoral Committee approves the research work reported in the synopsis, the candidate shall submit **three** copies of the approved synopsis to the COE **through proper channel**.

1. Synopsis should **contain title of the thesis**, outline **of** the research problem, the methodology used for tackling it, the organization of the thesis, and the summary of the findings.

2. The size of synopsis should not exceed 20 pages of typed matter.

3. The sequence in which the Synopsis should be arranged is as follows:

- i. Cover Page/Title page
- ii. Text divided into suitable Headings (numbered consecutively)
- iii. References (not more than 10)
